

M.A Indian Philosophy (P/T) - GI520

1. CONTEXT AND OBJECTIVES

Philosophy provides a base for critical and imaginative thinking and it gives one moral wisdom to make a good living and to richly contribute to the general good of the society. The study of Indian philosophy in the present context is relevant, as learners will find necessary tools for analysis, interpretation, argumentation, and deeper understanding of social, political, religious, metaphysical and other issues. The methodologies that Indian philosophy offers are important to the civil society as they enable one to understand the multi-perspectivity of truth by listening, examining and contemplating.

The objective of this Master's degree is to accommodate undergraduates in philosophy with a view of developing an advanced competence in Indian Philosophy. The programme aims to develop a research oriented focus on epistemology, ontology, axiology and philology. With a special focus on Indian Philosophy, the programme promotes a dialogue between the Classical and Contemporary fields and sub-fields of Western Philosophy. It includes elements of Sanskrit language that equips learners with necessary tools for philosophical analysis of texts. It opens avenues to conduct interdisciplinary studies and research in philosophy, humanities and sciences, thus enabling learners to extend their acquired philosophical skills and knowledge in various professional pursuits.

Competencies and Career opportunities

The modules are distributed at two levels- Level I and Level II, with the first three dealing with problematics in philosophy, with Sanskrit as a transition to textual analysis and the remaining focusing on research perspectives. In this way, they empower students with skills and attitudes to specialize in the subjects which best suits their intellectual growth and interests. They further open up broader avenues for undertaking research and other projects.

Job prospects for graduates exist in the fields of teaching, philosophical counselling, digital humanities and research among others.

2. LEARNING OUTCOMES

After successful completion of the programme, graduates should be able to:

- ✓ Explain advanced epistemological, ethical and metaphysical concepts
- ✓ Develop in-depth understanding of philosophical problems
- ✓ Evaluate major philosophical positions in relation to each other
- ✓ Critically discuss on social, moral and intellectual issues
- ✓ Apply research skills necessary for writing a dissertation that engages primary, and where applicable, secondary sources on areas of philosophy and
- ✓ Identify their own philosophical areas of interest and investigate them from various perspectives.

3. TEACHING AND LEARNING METHODS

Blended Mode: Face-to-face Lectures, Group Discussion/Work, Assignments, Tutorials, Problem-solving, Presentations/Seminars, E-learning (G-Suite/ Zoom/Moodle and others).

4. ENTRY REQUIREMENTS

- **General Requirements**

Successful completion of an undergraduate degree with

- at least a Second Class or 50%, whichever is applicable or
- a GPA not less than 2.5 out of 4 or equivalent, from a recognised higher education institution.

- **Programme (Specific) Requirements**

B.A (Hons) Degree in Indian Philosophy or B.A (Hons) Degree in Philosophy or equivalent qualifications acceptable to the UOM/MGI.

- **Exit points:**

The student can exit the programme with a Post-graduate Diploma or a Post-graduate Certificate as follows:

- Students may exit with a Post-graduate Diploma in Indian Philosophy after having earned 48 LCCS credits.
- Students may exit with a Post-graduate Certificate in Indian Philosophy after having earned 24 LCCS credits.

7. ASSESSMENT AND DEADLINES

All modules will be assessed over 100 marks

7.1 Examinations: 50% - 60%

Examinations will count for 50% to 60% of the total marks.

Each module will have a written examination of a duration of 3 hours at the end of the semester.

7.2 Continuous Assessment: 40% - 50%

Continuous assessment will count for a range of 40% to 50% of total marks. Continuous assessment will be based on two (2) assignments and should include at least one class test per module.

For a student to pass a module, an overall total of 40% for combined continuous assessment and written is required.

7.3 Submission for Dissertation

Students are required to submit an e-copy of their dissertation to their Project/Dissertation Supervisors through Google class at latest by 5.00 pm on date specified in the Calendar of Activities.

The Google class will be created by the Project/Dissertation Supervisor.

The e-copy of the project/dissertation (main body i.e. Introduction up to the Conclusion or last chapter) should be uploaded on the Turnitin Platform, as a single PDF file in the appropriate class/ assignment (final dissertation) provided by the Project/ Dissertation Supervisor
